4. Pre-bid meeting shall be held at Bheerkot Municipality Office, Bayarghari, Syangja at **2020 Mar 17**.
5. Sealed or electronic bids must be submitted to Bheerkot Municipality office through PPMO website [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on before 2020 Mar 29 at 12:00 Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **2020 Mar 29** at 13:00 the office of Bheerkot Municipality Office Bayarghari, Syangja. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of **Rs.400,000.00** which shall be valid for 30 days beyond the validity period of the bid **2020 Jul 27**.
7. If the last date of submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
